- A copy of duly self-attested EWS Certificate (valid for the financial year 2024-25)/ Caste Certificate for OBC (NCL) (valid for the financial year 2024-25), Caste Certificate for SC & ST awardees and Disability Certificate for Persons with Disability. All documents should be dated before the last date of the submission of application, i.e., 10th September, 2024.
- Self-attested copies of Graduation and Post-Graduation Marksheets together with university approved CGPA to percentage conversion formula.
